HOWEVER, FROM THE OUTSET, THERE HAVE BEEN STUDIO-TRANSMITTER LINK PROBLEMS AND KIDS FIRST, INC. IS CONTINUING TO WORK WITH THE PHONE COMPANY TO RESOLVE THE DSL LINK SYSTEM PROBLEMS. WITT-FM IS NOW OFF-AIR, AND IT MAY BE SEVERAL WEEKS BEFORE THE PHONE COMPANY DSL STUDIO-TRANSMITTER LINK ISSUES ARE RESOLVED TO WITT'S SATISFACTION.
